

BYLAW NO. 238-08

A BYLAW IN THE TOWN OF PONOKA IN THE PROVINCE OF ALBERTA TO AMEND BYLAW NO. 2-91

WHEREAS pursuant to the Municipal Government Act, Statutes of Alberta, 1994, Chapter M-26.1 as amended or replaced from time to time, Council may pass a bylaw respecting public utilities;

AND WHEREAS Bylaw No. 2-91 was passed on February 12, 1991 to provide for the use, levying, and collection of service charges, rates, and penalties in connection with the Town of Ponoka Waterworks and Sanitary Sewer System;

AND WHEREAS Council of the Town of Ponoka deems it necessary to adjust the rates and charges set out in *Schedule A* and *Schedule B* and *Schedule C* of Bylaw No. 2-91;

NOW THEREFORE COUNCIL OF THE TOWN OF PONOKA DULY ASSEMBLED ENACTS AS FOLLOWS:

1. That *Schedule A* and *Schedule B* and *Schedule C* hereto attached and forming part of this bylaw replace *Schedule A* and *Schedule B* and *Schedule C* of Bylaw No. 2-91;
2. That Bylaw No. 214-06 be repealed.
3. That this Bylaw shall come into effect March 1, 2008.

SCHEDULE C

(Effective March 1st, 2008)

The following rates will be charged for solid waste services within the Town of Ponoka, effective March 1st, 2008.

Solid Waste Collection and Disposal Fee

Each household unit \$12.15/month*

*Note: There will be a limit of two garbage receptacles per residential pick up, each week.

Yearly fee \$90.00 for each additional garbage receptacle rented from the Town.

*Note: Payable in advance for each additional residential receptacle over the two container limit

The following rates will be charged for solid waste disposal services at the Town Waste Transfer Facility, effective March 1st, 2008:

Solid Waste	\$ 60.00 per tonne
Scrap Metal	25.00 per tonne
Propane Bottles	5.00 each
Tree Stumps	5.00 each
Dry Clean Burnable Wood	10.00 per tonne
Concrete/Asphalt	15.00 per tonne

Compostable Material..... (Grass Clippings, Garden Waste, Leaves and Branches)	No Charge
Branches	No Charge
Minimum Tipping Fee.....	5.00

* *Tipping fees for residential contractor are based on existing contract.*
